Therefore, repercussions from labour markets outcomes on product demand - and vice versa - are absent. 55 Moreover, neither the process of capital accumulation, be it physical or human capital, nor substitution possibilities between labour and capital in the firms' production function are taken into account. Finally, international competition is not modelled.
